- This agreement will remain in effect for all subsequent procedures conducted by your technician.

### **3. Aftercare Instructions:**

- Following the aftercare instructions provided by your technician is essential to maintaining the longevity and health of your eyelash extensions. Failure to adhere to these instructions may result in the premature falling out of the extensions or other adverse effects.

### **4. Photography Consent:**

- By receiving our services, you consent to having pictures taken of your eyelashes, which may be used on social media for promotional purposes. If you have any objections, please inform us prior to your appointment.

### **5. Liability Waiver:**
